The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase :

On 13 October 2015 (the “first date of sale”):

Balloting will be used to determine the order of priority.

Persons interested in purchasing any of the specified residential properties (the “Registrant”) must follow the procedures below:-

1. For the avoidance of doubt, all valid Registrations of Intent (if any) previously submitted to the Vendor prior to the first date of sale will not be included in this balloting.
2. Registration slips will be distributed at Riva Shopping Arcade, No.1 Ying Ho Road, New Territories (“designated venue”) on the first date of sale (from 1:00 p.m. to 1:30 p.m.)(“check-in timeslot”). A Registrant (if the Registrant is a company, then all of its directors) must personally attend the designated venue and submit

- (a) only one registration slip duly completed and signed by the Registrant;
- (b) the registration slip shall be accompanied with one (1) cashier order in the sum of HK\$600,000 and made payable to “WOO, KWAN, LEE & LO”;
- (c) a copy of the Registrant’s H.K.I.D. Card(s)/Passport(s); and
- (d) (if the Registrant is a company) a copy of the Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary

to the designated venue on the first date of sale within the check-in timeslot. Registrant who arrives at the designated venue beyond the check-in timeslot shall not be eligible to participate in the balloting. The closing time for submission of registration slip will be 1:30 p.m. on the first date of sale.

- 3. Each Registrant shall only submit one registration slip, which when accepted by the Vendor, will only be valid on the first date of sale. Duplicated registration of Registrant will not be accepted. Late submission will not be accepted. The registration slip is personal to the Registrant and shall not be transferable.
- 4. The cashier order will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
- 5. After verification of the identity of the Registrants, the order of priority for selection of the specified residential properties will be determined according to the balloting which will take place at the designated venue. Every valid registration slip shall be allotted one (1) lot.
- 6. The Vendor shall not be responsible to the Registrant for any error or omission contained in the ballot results.
- 7. If a Registrant has successfully selected any of the specified residential properties, the Registrant will be offered to view the selected specified residential property(ies) and if the Registrant decides to purchase the selected specified residential property(ies), the Registrant shall **personally** enter into a Preliminary Agreement for Sale and Purchase of the specified residential property(ies) successfully selected by him/her. Before entering into the Preliminary Agreement for Sale and Purchase, the Registrant may notify the Vendor on spot to add any person(s) who is/are close relative(s) of the Registrant(s) (i.e. spouse, parents, children, brothers and sisters) as joint purchaser(s) subject to provision of adequate proof to the Vendor’s satisfaction of such relationship and that all the aforesaid persons shall sign the Preliminary Agreement for Sale and Purchase as purchasers personally.
- 8. If a Registrant has not purchased any specified residential property, his/her unused cashier order(s) will be available for collection by the Registrant (or his/her authorized person) at the designated venue immediately after the balloting mentioned in paragraph 5 above till 6:00 p.m. on the first date of sale. The Registrant must bring along the H.K.I.D. Card(s)/Passport(s) of the Registrant (or a copy of the H.K.I.D Card(s)/Passport(s) of the Registrant if unused cashier order(s) is/are collected by the authorized person) and (if applicable) copy of Business Registration Certificate of the Registrant, and (if applicable) a valid authorization letter and a copy of the H.K.I.D Card/Passport of the authorized person.
- 9. After the completion of the balloting and the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis and the balloting procedures stated above will not apply to the purchase of such remaining specified residential properties. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).
- 10. The Vendor reserves the right to close the designated venue at any time if all the specified residential properties have been sold out.
- 11. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 10:00 a.m. and 6:00 p.m. on **the first date of sale** and alternative arrangement is proposed by the Vendor regarding the first date of sale, details of such alternative arrangement will be posted on the website (www.riva.hk) designated by the Vendor for the Development.

On 14 October 2015 and thereafter:

- 12. Subject to the completion of the balloting and the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).

13. The Vendor reserves the right to close the designated venue at any time if all the specified residential properties have been sold out.
14. If the Vendor postpones the first date of sale to such other date due to the reason mentioned in paragraphs 11 above, the subsequent dates of sale will be postponed accordingly.
15. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 10:00 a.m. and 6:00 p.m. on any date of sale (other than the first date of sale) and alternative arrangement is proposed by the Vendor, details of such alternative arrangement will be posted on the website (www.riva.hk) designated by the Vendor for the Development.

2015年10月13日(下稱「出售首天」)：

以抽籤方式決定選擇住宅物業的次序。

有意購買任何指明住宅物業的人士(下稱「登記人」)須遵從下列程序：

1. 為免存疑，所有於出售首天之前已遞交予賣方的有效的購樓意向登記不會被納入是次抽籤。
2. 登記表格將於出售首天(下午1時至下午1時半內)(下稱「(報到時段)」)於香港新界映河路1號爾巒商場(下稱「指定會場」)派發。登記人(如登記人為公司，則所有董事)須於出售首天報到時段內親自到指定會場，
  - (a) 遞交一份已填妥及由登記人簽署的登記表格。
  - (b) 登記表格須附有1張本票，本票的金額為港幣\$600,000及抬頭人須為「胡關李羅律師行」；及
  - (c) 登記人的香港身份證/護照；及
  - (d) (如登記人為公司)商業登記證書副本及已於公司註冊處登記之文件以顯示當時的董事及秘書的名單。於「報到時段」以外的時間才到達指定會場的登記人將不享有參與抽籤的資格。遞交登記表格截止時間為出售首天下午1時半。
3. 每名登記人只可遞交一份登記表格。如獲賣方接納，登記只在出售首天有效。重複的登記人登記將不會被接受，逾期恕不受理。登記表格只適用於登記人本人及不能轉讓。
4. 本票將會用作支付購買指明住宅物業的部份臨時訂金。
5. 賣方核實登記人身份後，登記人揀選指明住宅物業的優先次序會於指定會場以抽籤方式決定。每一份登記表格可獲分配一個籌。
6. 如抽籤結果有任何錯誤或遺漏，賣方無須向登記人承擔任何責任。
7. 成功選擇指明住宅物業的登記人將獲安排參觀其所選擇的指明住宅物業，如登記人決定購買其所選擇的指明住宅物業，登記人須親身簽署臨時買賣合約購買其成功選擇的指明住宅物業。在簽署臨時買賣合約前，登記人可即時通知賣方增加買方之人數，惟新加入之買家必須為登記人的近親(即配偶、父母、子女、兄弟及姊妹)，並提供令賣方滿意的足夠證明以證明該關係，並且所有前述人士須以買方身份親自簽署臨時買賣合約。
8. 如登記人並無購入任何指明住宅物業或其購入之指明住宅物業數目未達其於購樓意向登記內所填寫意欲購買之數目，申請人(或其獲授權人士)可於上述第5段提及的抽籤完結後至出售首天晚上6時內於指定會場辦理取回未使用的本票。登記人須攜同登記人香港身份證/護照正本(如以獲授權人士取回未使用的本票，則須攜同登記人香港身份證/護照副本)及(如適用)登記人之商業登記證書副本及(如適用)有效的授權書及獲授權人士之香港身份證/護照副本。
9. 當抽籤及合資格人士選購指明住宅物業完畢後，餘下的指定住宅物業(如有)將以先到先得形式發售，而上述的抽籤程序將不適用於購買該等餘下的指定住宅物業。如有任何爭議，賣方保留絕對權力以任何方式(包括抽籤)分配任何指明住宅物業予任何有意購買的人士。
10. 賣方保留權利在所有指明住宅物業已售出的情況下於任何時間關閉指定會場。

11. 如在**出售首天**上午 10 時至晚上 6 時的任何時間內天文台發出八號或更高風球信號或黑色暴雨警告而賣方對出售首天另作安排，該等另類安排的詳情將於賣方為發展項目指定的互聯網網站的網址（[www.riva.hk](http://www.riva.hk)）作公布。

12. 在根據上述程序完成抽籤及合資格人士選購指明住宅物業的前提下，餘下的指定住宅物業（如有）將以先到先得形式發售。如有任何爭議，賣方保留絕對權力以任何方式（包括抽籤）分配任何指明住宅物業予任何有意購買的人士。
13. 賣方保留權利在所有指明住宅物業已售出的情況下於任何時間關閉指定會場。
14. 如賣方因上述第 11 段之原因延遲出售首天至其他日期，其後的出售日期將會順延。
